Large, mature tree: To contain spread and improve light and space all round and to continue to control root activity and trunk expansion: Reduce crown all round by 25 - 30% to previous reduction points, retain crown continuity. Thin and clean out crown, remove deadwood and suckers. Retain maximum screening within middle and lower crown areas.
