T2 - Horse Chestnut - Crown lift skirt to 5.5m, remove deadwood, shorten lateral which has broken to the West by 3m, reduce overlong laterals extending over gardens to the North by up to 4m to suitable unions - works to reduce weight on extended laterals, improve aesthetics of lower canopy.

T24 - Corsican Pine - Remove lowest limb on Southern side to prevent restriction to magnolia and improve light into surrounding beds

T30 - Beech - Remove deadwood to ensure continued safety
