1. The applicant wishes to omit a bedroom from the 1st floor and add a bedroom to the 2nd floor involving two additional side dormers providing natural light and ventilation to two bathrooms.

3. The applicant wishes to change the staircase sash window to a hand made stained glass window located inside a double glazed aluminium framed outer window.

The proposed variations to planning permission 2010/0945/P, with consented variation of condition 2011/0405/P and consented variation of condition 2011/5985/P:

1. Revised plans of 1st and 2nd floors to remove a bedroom at 1st floor and add a bedroom at 2nd floor.
2. Minor alterations to the design of the front entrance portico.
3. Omission of rendered walls to the side of the front entrance steps and provision of metal railings.
4. Minor amendment to the central dormers to the front and rear elevations.
5. Repositioning of the dormer to the West side elevation.
6. Resizing of the dormer to the East side elevation and the provision of two further dormers.
7. Redesign of three external ground floor doors to the rear elevation.
8. Omission of the timber sash window to the staircase on the East side elevation and the provision of a metal framed external/stained glass internal window.
9. Removal of ground level grilles and wall fixed plant to the East side elevation.
