FRONING ETON COLLEGE ROAD: (TPO REF 3H) - 1 x Horse Chestnut - Lift canopy
over the pavement by up to 2m
(TPO REF 3H) - 1 x Sycamore - Lift canopy over the pavement by up to 2m
(TPO REF 3H) - 1 x Horse Chestnut - Lift canopy all round by 2-3m and level off browse
line, clean out crown
BETWEEN ETON HALL AND ETON PLACE (FRONTING ETON COLLEGE ROAD)
(TPO REF 3H) - 1 x Lime - Lift canopy all round by 2-3m, thin lower crown by up to 50%,
removing all sucker growth, clean out upper crown
