The hardstanding forming the forecourt to the property is situated above the roof slab created by a basement to the front of the property granted permission in December 2006 (Application No 2006/5117/P). In addition to the area above the new basement, the remainder of the forecourt was reinstated as hardstanding as part of this consented development with the exception of a strip immediately behind the front wall of the property. This strip is shown either side of the front gate on Drg No 16ELS-001 P1 which was previously submitted to and approved by the Council as part of Application No 2012/4009/P. The hardstanding forming the forecourt of the property was replaced in July 2013 and surface run-off is directed to the porous areas towards the front of the property where hedging is planted. A small area of forecourt (less than 1 sq.m) which was previously porous has been surfaced.
