About 4 years ago, because the tree was diseased and with your permission, we started on a programme of removing one per year of the 3 trunk-like branches, which originated from the main trunk at about 6' high, in the hopes that the tree would respond by sprouting healthy shoots. This has not happened. We are left with a stump about 6' high, with a few thin shoots. It is not healthy and it is ugly. We propose to fell it and replace with one Acer Bloodgood, about 6' tall. We may not be able to plant it at exactly the same location, because of the roots of the hawthorn, but we will plant it as near as we can.
