Demolition of existing building and redevelopment for a mixed use building ranging from 6 -13 storeys comprising 2,220sqm employment floorspace (Class B1), 121 residential flats, the provision of a pedestrian footbridge with disabled access over the Regent's Canal, and associated landscaping and other works relating to the public realm.


The application does not lie within an Archaeological Priority Area. Although the applicant's heritage statement does not reference the Greater London Historic Environment Record and does not explicitly assess the site's archaeological interest it does show that the area was not development before the mid-19th century.

The GLIAS letter is mainly concerned with conservation area issues which are not my concern nor do I consider that there is sufficient archaeological interest to merit investigation given the late date of development and lack of significant historic features known on the site itself.

No further assessment or conditions are therefore necessary.

Please note that this response relates solely to archaeological considerations. If necessary my Historic Buildings and Areas colleagues should be consulted separately regarding statutory matters.
