ENFORCEMENT NOTICE

**OF 2a Agar Grove
London
NW1 9TD**

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. **THE LAND AFFECTED**

Land at: 2a Agar Grove, London NW1 9TD

as shown, for the purposes of identification only, outlined in black on the attached plan.

3. **THE BREACH OF PLANNING CONTROL ALLEGED**

Without Planning Permission: The unauthorised installation of UPVC windows on the property's front and rear elevation at ground, first and second floor levels.

4. **REASONS FOR ISSUING THIS NOTICE:**

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 years.
- b) The UPVC windows to the property's front and rear elevation at ground, first and second floor levels, by reason of their materials, design and means of opening are detrimental to the character and appearance of the host building and the attached neighbouring property, resulting in demonstrable harm to the character and appearance of the street scene and the Camden Square Conservation Area, contrary to policy CS14 (Promoting high quality

places and conserving our heritage) of the London Borough of Camden Local Development Framework Core Strategy and policies DP24 (Securing high quality design) and DP25 (Conserving Camden's heritage) of the London Borough of Camden Local Development Framework Development Policies.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

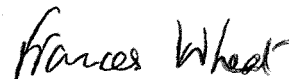
5. WHAT YOU ARE REQUIRED TO DO

The Notice shall require that within a period of **3 months** of the Notice taking effect the following works are undertaken:

- Remove all of the UPVC windows from the property's front and rear elevation at ground, first and second floor levels; and
- Re-instate the original design of timber framed windows and method of opening on property's front and rear elevation at ground, first and second floor levels.

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on **10 November 2014** unless an appeal is made against it beforehand.

Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002

If you appeal against the notice on Ground (a) "That planning permission should be granted for what is alleged in the enforcement notice, or that the condition which is alleged not to have been complied with should be discharged" there is a fee payable under Regulation 10 of the Town and Country Planning (Fees for Applications, Deemed Applications, Requests and Site Visits) (England) Regulations 2012/No.2920 for the deemed application for the planning permission for the development alleged to be in breach of planning control in the enforcement notice.

The fee is payable twice to the "London Borough of Camden", as the Local Planning Authority.

WHAT HAPPENS IF YOU DO NOT APPEAL

Failure to comply with an enforcement notice, which has taken effect, can result in prosecution and/or remedial action by the Council.
