ENFORCEMENT NOTICE

OF 14 Iverson Road London NW6 2HE

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. THE LAND AFFECTED

Land at: 14 Iverson Road, London NW6 2HE as shown, for the purposes of identification only, outlined in black on the attached plan.

3. THE BREACH OF PLANNING CONTROL ALLEGED

Without Planning Permission: The change of use of the basement, ground and second floors from HMO accommodation (sui generis) to x3 self-contained flats (C3) and x2 HMO bedsits (C4).

4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 years.
- b) The change of use from a House in Multiple Occupation (HMO) (comprising 8 bedsits) to x3 flats and x2 bedsit units (first floor only), would result in the loss of a low-cost form of housing for which there is demonstrable need in the Borough contrary to policy CS6 (Providing quality homes) of the London Borough of Camden Local Development Framework Core Strategy and policy DP9 (Student housing, bedsits and other housing with shared facilities)

of the London Borough of Camden Local Development Framework Development Policies.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO

Within a period of three months of the Notice taking effect:

- 1) The use of the above property as self-contained flats shall cease.
- 2) Remove any associated fixtures and fittings associated with the self-contained units including the locked door at the foot of the stairs between the first floor and second floor levels and the floor to ceiling partition and door to the left of the foot of the stairs at ground floor level.

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on **27 August 2014** unless an appeal is made against it beforehand.
