Dear Mr Dempsey - Thank you for sending the above letter announcing the application for great changes to the Heath with regard to possible flooding.

I do ask that this plan should be rejected on the grounds that it is not necessary.

When rain falls, it flows 'downhill' so the main problem for water running off the Heath is to ensure that the drains and access down to the Thames are sufficient and not blocked up. I have understood that the problem in 1975 which was the last time that there was flooding in Gospel Oak was exactly that - the drains were not adequate. Since then I do believe there are 2' storage tanks' and that there are 2 pipes 6feet diameter which carry, I can't remember how much water per minute, and I presume - down to the Thames - but I understood that that was sufficient to keep the water flowing off the Heath. There can be no value in creating large 'basins' for collecting water - most of the time these will be half empty or stagnant - it's not an enormous area. Urban London is and perhaps the drainage system for the residential areas is not adequate these days - so I am convinced that the answer lies in adequate sized drains.

We do live in a time of immediate communication with the world, so if a large storm breaks out we can all be alerted to possible trouble and get out of danger.

No firm should have been given a contract to carry out this completely devastating work on the Heath before looking at ALL the options. As I understand things - a firm of Dam builders has been commissioned to 'do this'. They might have been consulted - but I sincerely hope that the planning application will be turned down.

So thank you for hearing my small plea that it SHOULD NOT HAPPEN
