The tree is a 3m high Bay Tree and is NOT protected by a TPO. It is close (0.5m) to the garden side wall and close (1.5m) to the old end garden wall which I believe is listed. The tree is of little amenity value and shades an area of the garden that would otherwise be sunny. We would like to completely remove the tree as the garden is being replanted. It is anticipated that 3 new trees will be planted in the new garden, although species have yet to be confirmed. It is possible that they may include Amelanchier, Malus or Olive trees.
