Silver solar painted asphalt applied over plywood sheathing laid over existing roof sarking boarding and roof structure. Also applied over lead covered roof access dormer and over front parapet. Asphalt flashings, gutters and trims.

Welsh slate on s/w battens on breather membrane laid over existing sarking boarding. Lead hips with timber rolls. Lead gutters, flashings, and over parapet copings. Lead cladding to roof access dormer top and cheeks. Treated with patination oil on completion.
