We represent the residents of two sheltered housing schemes overlooking the development. One is at 4 Guilford Place WCIN1EA with 14 flats, one at Shan House, Millman Street with 18 flats. The Association is supportive of the scheme which will enhance the area and improve the amenity of both Akbar House and Shan House. The meeting resolved to make the following suggestions to Camden in relation to the scheme and delegated the Hon Sec to write to the planning authorities on its behalf. 1). Trees. The association is at pains to emphasise the extremely high amenity value of London Plane Trees 1,2, & 3 on the scheme plan. These are both much loved and form an integral part of the street scape in Guilford Place and the association is anxious that nothing should be done that would undermine their root systems or degrade their canopies. The association is concerned that the scheme proposal to prune London Plane Tree 1 so that there is a 2 metre gap between the edge of its canopy and the site is too extreme. Cutting the tree back to this extent risks unbalancing it as its trunk slants slightly away from the site and the canopy has grown to compensate. The new building line is well behind the site line and the overhang is over what will be a stone apron at the front of the new building so the shading will enhance and not inconvenience in any way. The Association agrees with the proposal to remove Tree of Heaven 4 on the plan. The Association would urge that Tree of Heaven 5 should also be removed. This self-seeded specimen already towers above the roofline of 3/4/5/6 Guilford Place and it blocks light to the gardens at the back making them gloomy and restricting the ability of residents to garden effectively. The bulk of the main block of the new building will inevitably further reduce light levels to these key amenity spaces for the residents of the Sheltered housing schemes and this effect can be countered by the removal of what is in any case a forest tree whi

We would prefer if it could be moved slightly so as not to be adjacent to the wall of No4 where the
