This is retrospective application for the fitting of rolling exterior security shutters on 9 Colonnade to match the existing shutters on our locations at 29-33 Colonnade. We were not aware in 2011 that PP was required as not only our other units at 29-33 Colonnade had shutters, but there are also many other shutters already on this street: Rear of tube station; gawdy orange ones at back of cafe diagonally opposite that are never opened and shutters at the end of road abandoned newsagents that are also never opened. At the time of fitting these the houses adjacent were derelict and uninhabited and drug dealers were a semi-permanent fixture at the end of the road. Our insurance requires us to have shutters, but when they are up during the day we have still had burglaries where moped gangs crowbar the doors in seconds and snatch whatever they see despite alarms. Crime reports and CCTV available. Please forgive poor draughtsmanship but no-one was willing to take on the drawings in the short time available after enforcement sent notice to the upstairs flat and not to us.
