Having consulted Neil Collins and having sent Neil the newly proposed drawings it was indicated the changes would be Minor Material amendments. It was presented to us we could process the changes by Non-material amendment, with the omission of a skylight and by not changing the material of the rear part of the extension from wood cladding to brick. It was decided the designs aesthetic and suitability to its context would be advantaged to such a degree to make the changes as we presented that it was more suitable to take the more laborious route for the betterment of the design of the project and so to submit for a Minor Material Amendment not a Non Material Amendment.

Please state why you wish the condition(s) to be removed or changed: We want to reduce the size of the previously proposed application to enable the rear and side extensions to fit more comfortably within the site. We would also like to																
change the material from timber to brick of the rear, not side, part of the extension to match the existing property. This will ensure the new proposal has more continuity with the existing building and in doing so will make overriding proposal feel less imposing. We also propose to reduce the glazing, pull the external terrace back and heighten the perimeter fence in response to neighbours concerns of overlooking and light pollution.

-Reduction of the rear and side extensions footprint. -Change of timber cladding to brick at the rear part of the extension -Move the balustrade back toward the property on FF terrace -Reduce the surface area of the proposed glazing -Build the perimeter fence at the height of the proposal- decided having consulted the neighbours at 35 Heath Hurst who voiced this to be their preference
