Large tree outside front of 166 Belsize Road causing structural damage to the lower ground floor property; including damp and large cracks. The tree is causing cracks to the communal stairs outside the front of the property which in turn causes damp/ cracks to the bathroom in the lower ground floor flat located beneath.

The tree needs to be removed completely as the damage is being caused by its roots and not the height size of the actual tree.
