I would like to seek planning permission for the roof area above the planned extension to be used as a terrace. This would be used by the residents of the first floor flat, and will be accessed by converting the existing window in the rear wall into a doorway. A balustrade would be installed around the perimeter of the terrace, and to create a sense of continuity and visual balance the balustrade of the neighbours existing roof terrace above would be changed to match. To offer privacy to the surrounding residents without blocking the light, the rear portion of the balustrade would be a frosted glass.
