The non-material amendments are:

- Dormers facing west are now pitched and have side windows in them-one of these (to Bedroom 5) is now considerably smaller in width than was consented.
- The existing circular bay window off the dining room on the ground floor is now square.
- All second floor windows are now leaded lights
- The Kitchen and Informal Dining windows are now crittall windows
- A skylight is to replace a consented dormer in Bathroom 4 (on the second floor)
- The basement is slightly longer from east to west, albeit slightly thinner in width and further from the existing building
- Windows WF07&08 have changed in position slightly.
- Solid timber replacement front gates.
