Following the below advice, we will not be installing on the column outside the phone box. St Giles: The site lies within close proximity to the Denmark Street Conservation Area to the south of St Giles. If at all possible it would be ideal if banners could be located on the north side of St Giles, adjacent to the new development. If they are to be located on the south side of St Giles then they should not be located adjacent to St George in the Fields Church or next to the existing phone box located nearby. The banner proposed on the Junction of Denmark Street and St Giles High Street (opposite banner no. 7 in your submission) is acceptable on the basis that it faces St Giles High Street and not Denmark Street. Banner no. 7 in your submission is also considered to be appropriate in the location.
