I strongly object to this for several reasons as outlined below</p> <p>The terrace appears to be partially completed already. I can see the structure clearly from my garden and living room.</p> <p>To date, I have politely complained a number of times to the people involved as they have been resting metal sheets and building materials against my fence causing it to lean at a 90 degree angle. On one occasion, builders exposed a gap between the ground and my fence and I was concerned that my dog would escape through the said gap.</p> <p>At present, the structure in place exceeds the height of my garden fence and is unsightly. I am very concerned that if permission is granted my privacy will suffer greatly. Customers will have full sight into my garden and also through my glass patio doors which will enable people to see directly into my living room. I am a single woman who lives alone and the prospect of this being approved makes me feel very uncomfortable and unsafe. I would most certainly have to improve the security of my home due to the extremely close proximity of this proposed public space and keep my curtains closed at all times. I fear that I would no longer be able to enjoy my garden and it may be littered also.</p> <p>Noise is also a concern. This area is a residential space with a number of gardens backing onto each other. Due to its location, my garden and home will be one of the most affected by this.</p> <p>I have no details as to how high this structure is proposed to be, but loss of light is a concern.</p> <p>If this is approved it will have a huge detrimental impact on my home life and personal security..</p> <p>The posts of the structure that are there already are flush to my garden fence. There is no more than an inch gap. The structure spans half of the length of my garden &amp; I estimate that it is no more than 15 feet away from my patio doors/living room.</p> <p>In my submission, it would not be appropriate to grant this planning application for the reasons outlined above,</p>

The owners and staff of the restaurant now consistently use the roof as a rest area; making phone calls, chatting, etc... and I can hear everything being said. Not only that, they can see directly into my flat, thus, I now do not open my curtains fully for privacy reasons and this obviously effects the amount of light entering my flat.</p> <p>I am self-employed and spend a large proportion of my time working from home. The nature of my work – researching, reading, writing screenplays, script editing, editing films and photographs - means that I require long unbroken periods of concentration and with the use of the roof as a commercial terrace, this would impact dramatically on my ability to carry out my business duties and therefore my earnings.</p> <p>During this summer, 2014, work was continually carried out on the restaurant and the roof was utilized as a workshop – heavy machinery was consistently used and the noise was unbearable and I found myself regularly having to use earplugs just in order to enable me to carry out my work. Therefore, more work on the roof means more noise, more distraction, and after a whole summer of it!</p> <p>To allow customers to dine on the proposed roof terrace, which backs onto a residential area, would be a nightmare. The amount of continual noise and the lack of privacy this would generate is totally unacceptable, and I am whole-heartedly against granting this planning application.</p>
