- 2) Goat Willow - Remove 2 x low branches and 1 x sub lateral, crown thin by 20%.
- 3) Apple - Open up and thin 20%.
- 4) Cherry - Grind the major root 300mm below soil.
- 5) Ash - Remove low lateral to the right, left reduce back 3.0mt. below previous and the rest reduce back to positions close to the previous reduction points. Leave as many side shoots or buds, as possible, and a natural flowing outline. This will facilitate a healthy recovery, any dead, dying and diseased wood will be removed.
