- The development hereby permitted shall be carried out in accordance with the following approved plans 237/00, 237/04 REVP2, 237/05 REVP2, 237/07 REVP2, 237/08 REVP2, 237/09 REVP2, 237/10 REVP2, 237/11 REVP2, 237/12 REVP2, 237/13 REVP2

Reason: For the avoidance of doubt and in the interest of proper planning.
