2 All new external work shall be carried out in materials that resemble, as closely as possible with those of the existing building, including painting the proposed timber panels white, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 and DP25 of the London Borough of Camden Local Development Framework Development Policies.

The development hereby permitted shall be carried out in accordance with the following approved plans 1401 (0) 101 P1, 1401 L(0) 110 P1, 1401 L(0)300 P1, 1401 (0) 310 P1, 1401 L(22) 100 P1, 1401 (0) 701 P1.

Reason: For the avoidance of doubt and in the interest of proper planning.
