My concerns centre on its impact upon the area where I live and the neighbouring streets (Shaftesbury Avenue, New Compton St and Stacey St). By its very nature, restaurants of this type will attract customers late at night that have been out drinking and socialising in the area. The increased pedestrian traffic late will bring increased anti social behaviour and noise. Such problems are already considerable in the area, especially at weekends. I am also concerned about the early opening hours and the increased traffic that will result if deliveries etc are made in this area and the associated disturbance to sleep that this would cause.

The business is, in my opinion, not suitable for the gateway to Covent Garden, a vibrant internationally renowned destination with many individual boutique shops, cafes and restaurants. Nor is it suitable for Soho which has been trying to improve its image over recent years. Allowing such a business to open with the anti social hours proposed will increase rubbish on the streets and thus rats, will disrupt residents through increased noise from customers as well as from deliveries, and will further degrade the pavements and roads through increase of traffic. It is likely to increase the problem of antisocial behaviour which already exists in the area of Phoenix Street, Stacy Street and New Compton Street. If MacDonalds is to open at Cambridge Circus I believe that the very least to be done would be to keep opening and delivery hours restricted to the normal times for the locality which I understand to be 8am to midnight Monday to Sunday.
