Remove any major deadwood that remains. Crown thin remainder of crown 15% Remove ivy to ground level and remove stems growing within 1m of main stem to limit redevelopment

T3 Lime
Crown reduce height and spread 25% to previous reduction points (most recent), retaining some soft epicormic growth Remove small low branches selectively where growing at 45 degrees to improve appearance and balance overall shape

T4 Hornbeam
Fell to ground level

T5 Hornbeam
Fell to ground level
