## Proposal:

(TPO Ref: 31H) FRONT GARDEN: 1 x Rowan - Structural prune to promote development of the desired or natural form. Remove poorly attached branches. Remove dead and broken braches.

2 x Cherry - Remove lower branches to a height of 2-2.5m. Structural prune to promote development of the desired or natural form.

Subordinate rapidly growing lateral branches. Remove poorly attached branches. Remove and and broken branches.

Remove lowest branches.

REAR GARDEN: 1 x Purple Leaf Plum - Thin crown to remove approximately 15%.

2 x Birch & 1 x Cherry - Clean to remove all dead, diseased and broken branches 2 centimetres in diameter and larger throughout crown.

1 x Winter Flowering Cherry - Reduce branch by approximately 1-1.5m.

The Council has considered your application dated 15 July 2014 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:



1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.

Reason: To allow the Council to monitor the completion and standards of the work.

2 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the tree(s).

Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
