Camden Council have had to visit the site regularly because of safety,parking,noise and environmental reasons and I suggest you speak to Mr Talbot in Camden Planning for evidence and further details.</p> <p>1.Health and Safety As well as children crossing the road frequently from the park,residents need access to the library on foot and by car.In Antrim Grove there is a 93 year old lady and a home for vulnerable adults.It is therefore essential emergency access is available to this area.I am sure you are aware recent stroke treatment guidelines say that treatment should be administered within an hour of symptoms to increase chance of recovery .Waiting 20 mins for an ambulance as it is blocked in by trucks to reach us will obviously impact on our health</p> <p>2.Area of vulnerable groups As above the area serves small children,the elderly ,the community and there are several children in this area sitting exams and noise levels will interfere with their ability to study and so affect their education</p> <p>3.Disruption With current basement building work we are exposed to high levels of noise WITHIN our houses such that it is almost impossible to work at home.Lorries arrive at 7 30 am so we are blocked in and cannot do school runs or get to work.Building work includes Saturday mornings.Basements work requires large cement trucks to regularly come to the road for long periods of time.In the last 6 months the road has been blocked to all traffic all day blocking access to emergency vehicles.The tranquility of a Saturday morning lie in is a distant memory .</p> <p>4.Conservation Cement from trucks is currently caked to the kerb and now has cigarette butts and rubbish embedded into it.It is hard to see that an estate agent sign cannot be displayed yet the dirt in a conservation area is allowed.Further building work would only further harm the area.</p> <p>5.Access Frequently we cannot leave our houses in the mornings as we are regularly blocked in.We cannot use our garages as they are often blocked by trucks.</p> <p>6.Co-ordination of multiple major building works In Antrim Grove ,which is a small stretch of houses, there are already major building works-a basement project at 8 Antrim Grove and planning permission for 1 Antrim Road for a basement has just been granted.In addition number 1 and 3 Antrim Grove ie opposite number 6 are about to start whole house renovations . This will mean that we residents in the middle will be surrounded by work ,builders and their major deliveries .We will not be able to reach our houses and the noise will be intolerable.</p>
