(TPO REF C36) WITHIN ENCIRCLED GARDENS: 1 x Horse Chestnut - Crown lift skirt to 5.5m, shorten broken lateral to the west by 3m, reduce overlong laterals extending over gardens to the north by up to 4m to suitable unions

1 x Corsican Pine - Remove lowest limb on southern side
