Proposed Work:

WITHIN GROUNDS OF OAK HILL PARK: 1 x Sycamore - Remove lowest lateral branch (150mm diameter) at 4m

- 1 x Sycamore Reduce crown by 20%
- 1 x Beech 10-15% crown reduction
- 1 x Lime Remove basal growth, 15% crown reduction, lift canopy to provide 4m crown clearance
- 1 x London Plane Remove 5m from top
- 1 x London Plane Reduce crown by 15%
- 2 x Lime Reduce height by 5m, remove lateral branches growing towards building to a height of 4m
- 1 x Sycamore 20% crown reduction, left crown to 4m
- 2 x Lawson Cypress Remove
- 1 x Cedar Reduce height and crown spread by approx 2x

The Council has considered your notification of intended works to trees dated 15 October 2014 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, which ever is the sooner.
- You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
