| Tree No. 1: Sycamore This tree requires a lateral reduction by removal of long low limbs and lateral reduction of other limbs to reduce by approximately 2 metres on garden side. This is to create more light for the border below. |
| Tree No. 2: Horse Chestnut This tree requires lateral reduction by approximately 1.5 – 2 metres back to previous reduction points on garden side for light around the border and to control lateral spread. |
