## Site Description

Senate House is Grade II \* listed and was designed by Charles Holden in 1932-38. The building is a monumental Portland stone faced structure which rises at its centre to an 18 storey tower. The building is a local landmark for the University of London and dominates Malet Street. The building also stands within the Bloomsbury Conservation Area.

### **Relevant History**

Listed Building Consent (2008/1625/L) was **granted** on 11 July 2008 for "Internal alterations and formation of new library reception in third floor lift lobby area of Senate House."

Listed Building Consent (2014/3885/L) was **granted** on 2 September 2014 for "Removal of two timber framed plasterboard studwork partitions on the third floor to allow the expansion of the adjacent library reading room, and installation of mobile shelving."

#### Assessment

The original plans show that the two rooms in question been a single room that had been originally intended to be used as staff changing rooms. The use was later changed to that of offices.

The application proposes the removal of a timber stud partition between two rooms 353 and 354 on the third floor of Senate House. The applicant evidences that it was inserted in the 1980's. The application scheme proposes to return these rooms to the original configuration of one room. There will be no adverse impact on the fabric, character or significance of the listed building and the proposed reconfiguration will improve the internal setting.
