Prune Acacia (ID# 3) located at the front of house/boundary tree according to the following specifications:

Clean to remove all dead, diseased and broken branches 2 centimeters in diameter and

larger throughout crown to improve health and appearance and reduce risk of branch failure.

• Reduce crown height and spread by approximately 2-2.5 meters to reduce risk of branch,

stem and/or root failure.
