Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 and DP25 of the London Borough of Camden Local Development Framework Development Policies.

- 3 You are reminded that the condition 3 in relation to application 2013/1470/P which was approved at appeal on 13th December 2013 still needs to be discharged.
