1 Ash

Very large, mature, twin stem tree very close to the rear elevation of the adjacent property and approx. 0.5m from the boundary wall. Any cracking to this wall does not warrant the removal of this tree. However: In order to contain spread, improve light and space and clearance all round and to retard root activity and trunk expansion sufficiently: Pollard crown to original trunk knuckles.

rear left side

2 Cherry

Mature tree. To contain spread and improve light and space all round: Reduce crown all round by approx. 2m to previous reduction points, retain crown continuity, clean out and balance crown.

rear centre

3 Laburnum

Reduce and reshape to contain spread and balance.
