The lifting beam will be formed out of steelwork and attached to the existing plant and machinery.
The lifting beam will be used to facilitate maintenance work on the batching plant allowing materials to be lifted into place without having to bring in a mobile crane. In turn this will bring about health and safety improvements to the operation of the plant.
