Re: 6 Glenmore Road 2014/4519/P (flats 1st & 2nd floors)

The second planning application I have looked at is for the above address, application ref 2014/4519/P. Unlike the first one I looked at, this is coherent and well presented. The whole house is being renovated and extended but with minimal impact on its exterior appearance in my view.

At the front, the existing shallow light well for the basement is being lowered, accessed by a new metal staircase, and the existing very small windows replaced by timber French windows matching the style of the windows on the ground floor. On visiting the site this morning, I can see that for numbers 2, 4 and 6 the current ground and first floor windows are fairly modern replacements, compared to most of the rest of the street, but they are wooden at least and not upvc, and broadly follow the original glazing plan.

As the attic space is being converted, they also want to add two velux conservation rooflights, and replace the one currently on the roof with a new one to match

At the rear - no.6 is the one on the far right of this pic - they want to have 3 more conservation rooflights, and the small rear extension is to be rebuilt on the existing footprint. The new wooden windows are to match the other windows on the rear facade, and the extension is to have a flat roof. I am also attaching the existing and proposed front and rear drawings, so I hope you will agree that the proposed changes are reasonable The proposals include extending the existing basement to 4m out under part of the garden, to be lit by three walk-on glass skylights. Perhaps we should comment that these should be fitted with blackout blinds to reduce light pollution by night. I might add as well that though I have no objection to the skylights in the garden, I would prefer to see rather less paving, or at least permeable paving over this small outdoor space. (The rear is north facing, so any grass would get full of moss I expect.)

My view as you will have gathered is to say no objection, with just a couple of comments about the basement skylights and the paving.
