#### **ENFORCEMENT NOTICE**

1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

#### 2. THE LAND AFFECTED

Land at: Knollys House, 39 Tavistock Place, London WC1H 9SA as shown, for the purposes of identification only, outlined in black on the attached plan.

#### 3. THE BREACH OF PLANNING CONTROL ALLEGED

**Without Planning Permission:** The installation of 1 x uPVC window on the front elevation at lower ground floor level.

#### 4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 years.
- b) The uPVC window to the property's front elevation at lower ground floor level, by reason of its material and design is detrimental to the appearance of the host building and the attached neighbouring property, resulting in demonstrable harm to the character and appearance of the street scene and the Bloomsbury Conservation Area, contrary to policy CS14 (Promoting high quality places and conserving our heritage) of the London Borough of Camden Local

Hances Wheat

Development Framework Core Strategy and policies DP24 (Securing high quality design) and DP25 (Conserving Camden's heritage) of the London Borough of Camden Local Development Framework Development Policies.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

#### 5. WHAT YOU ARE REQUIRED TO DO

Within a period of 3 months of the Notice taking effect:

- 1. Remove the 1 x uPVC window from the property's front elevation at lower ground floor level; and
- 2. Re-instate a timber framed window to match the design and opening methods of the original windows in the rest of the property.

#### 6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 3 February 2015 unless an appeal is made against it beforehand.


