The Council considers it necessary to issue this notice for the reasons set out in paragraph 4 below.

3. THE CONTRAVENTION ALLEGED

Without listed building consent: Replacement timber double glazed windows to front and rear elevation of existing dwelling house (Class C3)

4. REASONS FOR ISSUING THIS NOTICE

- a) The work outlined above has been carried out to this Grade II listed building without the benefit of Listed Building Consent.
- b) The replacement of the original single glazed sash windows with double glazed units, by reason of their detailed design and the different reflective quality of the replacement glazing, are harmful to the special architectural and historic interest of the listed building and its setting and is therefore contrary to policies CS14 (Promoting high quality places and conserving our heritage) and DP25 (Conserving Camden's heritage) of the London Borough of Camden Local Development Framework.

5. WHAT YOU ARE REQUIRED TO DO

Within a period of **six months** of the Notice taking effect:

1) The unauthorised double glazed timber windows on front and rear elevations shall be removed and replaced with traditional single glazed timber windows to match the original historic windows.

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on **2 February 2015**, unless an appeal is made against it beforehand.
