For your particular information, and in support of their application, you should know the following:

Truffles started the annual York Rise street party which has brought the local community together for a day of events to raise money for charities;

It has a loyal local clientele who want to ensure that the business remains at the heart of our community providing a service which is truly exceptional and very much appreciated;

There was an off-licence in Chetwynd Road which, despite repeated changes of owners, didn't have sufficient trade to keep paying the rent and rates, so there is room in the area for a good, yet modest, range of well selected wines to be on sale.
