The existing block as it is, causes light pollution at night (the fluorescent lighting in the block shines directly into my flat up to 10 p.m. most nights including weekends and there is sometimes noise as well). If this part of the new building is intended to be used in the same way as the existing building , it will be intolerable and will probably lead to constant protests about noise and light pollution rom residents. This view to the old school building when approaching the Heath from Dartmouth Park is a significant asset to the neighbourhood.

I would like to object on several grounds: 1. not least of these objections is inadequate local engagement (for example the residents immediately opposite were not even informed initially). 2. the scale and extent of the buildings are excessive and will totally dominate the whole of the Highgate road approach to the Heath for generations. The proposals are in extremely modern unsympathetic style, do not match the existing (excellent) frontage and will 'stick out like a sore thumb': the proposed developments are simply not in keeping with existing scales and styles of surrounding buildings. 3. The proposals are, simply, ugly and need to be revised. 4. The obstruction of the beautiful existing brick facade from the street will deny existing views to the public that are enjoyed by far larger numbers than simply live locally - this is a very major access route to the Heath.
