Prune Lime x 4 group located at the front of house according to the following specifications:

- Clean to remove all dead, diseased and broken branches 2 centimetres in diameter and larger throughout crown to improve health and appearance and reduce risk of branch failure.
- Remove lower epicormic shoots to a height of 4-5 metres to improve clearance over grade.
- Reduce regrowth back to previous parts by approximately 2-3 metres to manage volume.

Prune Apple located at the rear of house according to the following specifications: • Clean, thin and reduce crown as necessary to promote fruit production and quality. Fruit tree pruning will reduce the risk of branch failure due to excessive fruit production

Prune Bay located at the rear of house according to the following specifications:

- Reduce crown height by approximately 1-1.5 metres to enhance formal shape.

Prune Laburnham located at the rear of house according to the following specifications:

- Reduce crown height and spread by approximately 1-1.2 metres to reduce risk of root failure.

Prune Lombardy Poplar x 3 group located at the rear of house according to the following specifications:

- Clean to remove all dead, diseased and broken branches 2 centimetres in diameter and larger throughout crown to improve health and appearance and reduce risk of branch failure.
