Currently there are some bespoke black steel access ladders to the roofs of the building with integrated key clamp wires. There are also black railings acting as barriers to the edges of some of the flat roofs. Description of <i>proposed</i> materials and finishes:						
Proposed to install a wire based fall restraint system to the pitches of the roofs to the front and rear of the buildings.						
System to be latchways traditional Class B1 restraint system with supporting posts, posts to be weathered into the roofing using code 4 lead work and other materials sympathetic to the heritage of the building. The existing ladders and railings are to be refurbished and in some cases replaced like for like.
