Large, mature, previously reduced tree. This tree has a wound at ground level on the Northwestern side of the stem. The wound is approx. 45-50cm wide at its widest point and extends up and tapers off at approx. 1m. The wound was probably caused by the loss of a sub-dominant stem in the past. There is a fungus feeding on the dead wood within the wound.

The fungus is *Auricularia mesenterica*. This fungus is primarily saprophytic but can be weakly parasitic attacking exposed and/or dysfunctional wood. The fungus can lead to failure of trunks and branches through hollowing.

The tree is getting smothered in ivy and this adds weight and an evergreen sail to the tree. To reduce the mechanical loading on the tree and reduce the likelihood of failure, the suggested works are: To

reduce the tree back to the previous points of reduction, remove deadwood and ivy.
