T1 London Plane x 2

Extra large, mature, widespreading trees. These trees overhang several properties and they are blocking light. The access to the trees is through the house and they overhang the rear of businesses on Parkway. To reduce the mechanical loading on the trees and reduce the moisture loss from the soil, the suggested works are: To reduce the overall height by 3-3.5m, reduce the lateral spread all round by 3-3.5m, thin through crown by 5-10%, remove deadwood @ £1980 each.

Rear right

T2 Pear x 1

Mature tree. This tree is outgrowing its location and is getting smothered in creeper and climbing rose. The extra weight and sail area added to the tree can lead to limb failure or windthrow. The suggested works are: To reduce and re-shape all round by 1-1.5m, remove rose and creeper down to the trellis, clean out crown, remove deadwood.
