The proposed glazed windows, if permitted, would look completely out of place on the ground floor of this historic public house.



I am writing to you as a resident who is very concerned and objecting to the application by Foxtons to install floor to ceiling windows on the Kentish Town elevation and on the Patshull Road elevation of the shopfront.

I live on the first house on Patshull Road, opposite the building in question, with my windows overlooking it. The proposed changes to the windows – from a traditional historical building to a commercial shop, completely changes the character of both the building and of my road. Further to my letter and the email I sent a few minutes ago (see below), I would like to say that from a personal point of view, I really do not want the view from my home, which is opposite the building in question, to be that of a brash estate agent with floor to ceiling windows, logos, fluorescent lights and cars covered in advertising. I bought a flat on a residential road, and being London I was quite happy for there to be a traditional-looking pub opposite my home - I did not expect there to be a commercial shopfront with advertising glaring at me. I know this is not something that forms part of the planning application, but I do want you to consider how massive a change this would be to the environment of Patshull Road.

The construction work in changing the pub would also be extremely disruptive - these companies never stick to the working hours they are permitted to and I had to make dozens of noise complaints to the council last time Annie's was altered (which the council didn't action for over 2 months).
