I am unable to access the link to post the objection. The application ref. is 2014/7602/P.

My name is Linda Deppa.

I live at Flat 1, 5 Hemstal Road NW6 2AB. My flat is directly below the flat where the rear extension and associated terrace is proposed.

My objections are as follows:

1. I am concerned about the loss of light and lack of privacy of the proposed work. The proposed roof terrace will directly overlook my private rear garden. The extension will also cast a shadow over my rear garden, blocking out light. Due to the way the house is converted I only have windows/natural light from this side of the building which will be severely impacted.
2. I am concerned about the noise from the new use. The proposed terrace is intended for use and will lead to noise and disturbance to myself and my family when it is in use. I also feel that the privacy of my garden will be violated.
3. I am intending to work as a child minder from home and am therefore concerned about the impact of noise from plant equipment.
4. Both the London Borough of Camden, who were the building freeholders until last year, and the new freeholders are aware of the severe structural issues with Flat 1. The proposal plans to build on a structure which is already severely compromised lead me to believe this will be dangerous and compromise the safety of my family.
