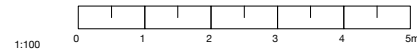
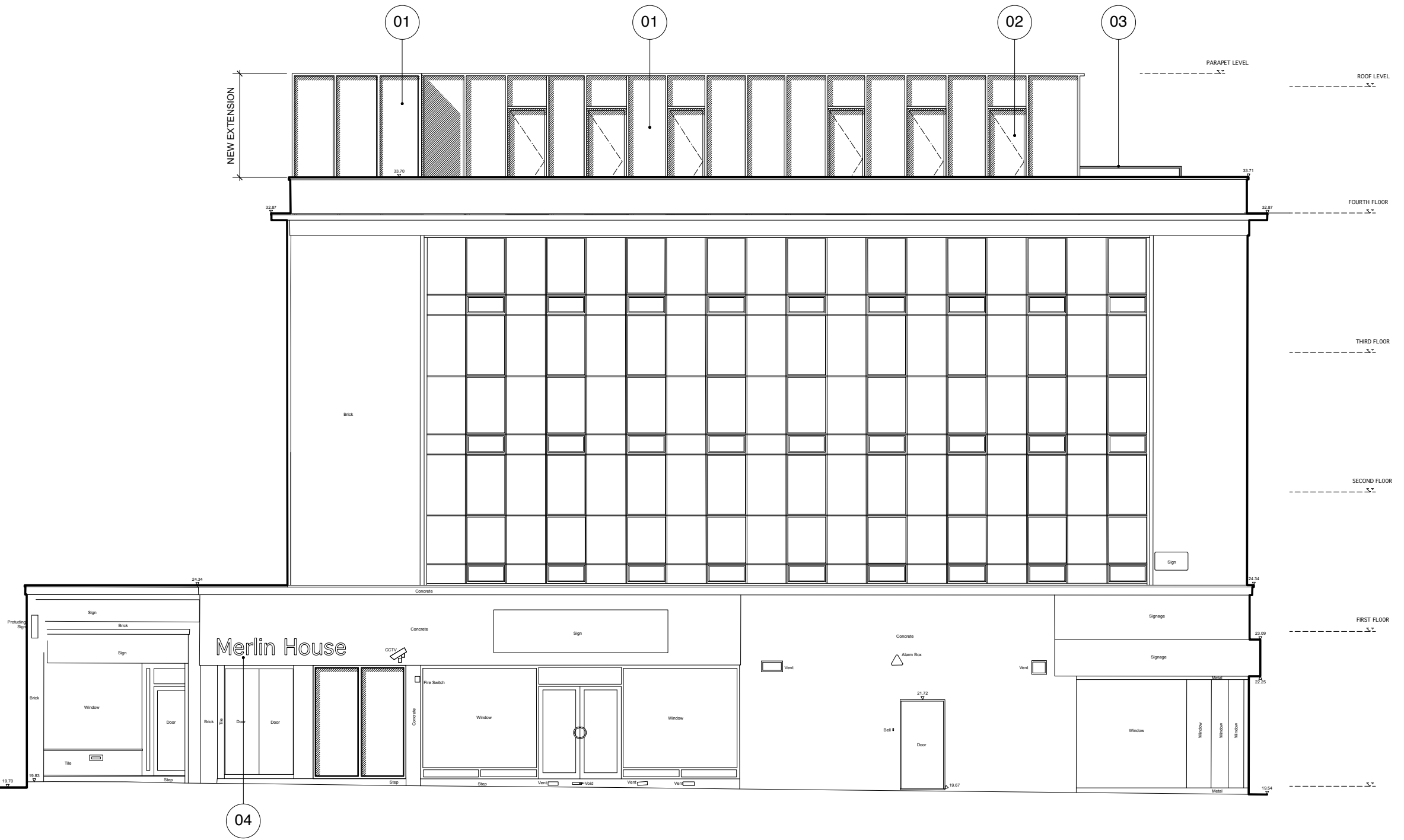


- 01 Pre-weathered Zinc Cladding (VM ZINC PIGMENTO verte/green)
