Reasons for Refusal

The proposed externally illuminated, large, high-level sign would, by virtue of the combination of its prominent location, size and illumination, be detrimental to the visual amenity and character of the street-scene, resulting in visual clutter and undue visual intrusion into the general street-scene.

Assessment

Proposal

The application relates to 3 shroud screenings printed on PVC and positioned to the front and side elevations of the premises. It is proposed that a front elevation shroud measuring 18.8 x 16m contain a commercial advertisement, and the remaining north and south side elevation shrouds, measuring 12 x 6m and 8.4 x 12m respectively, carry publicity for the Camden Market Area. External illumination would be applied to the front elevation shroud by means of LED strip or spotlighting. The shrouds are not intended to provide temporary display - consent is sought for 5 years - and there are no current or confirmed future construction or repair works at the premises for the shrouds to mask.

The Town and Country Planning (Control of Advertisements) Regulations 2007 permits the Council to only consider amenity and public safety matters in determining advertisement consent applications.

Amenity

Camden Planning Guidance (paragraphs 8.20 to 8.22) acknowledges that shroud advertisements can help to shield unsightly construction work, but is clear that as a result of their scale and size their appearance can create a conflict with the surrounding environment and street-scene. To avoid this CPG1 stipulates that shrouds on scaffolding are only permitted where:

- They screen buildings under construction, alteration or refurbishment. If considered acceptable
 they will be allowed for a temporary period and should be removed on completion of the works
 should they be sooner than the approved period.
- The scaffolding covers the entire elevation of the building and the netting on the scaffolding contains a 1:1 image of the completed building which is undergoing construction work (scaffolding is only to be erected for the purposes of carrying out building works and will be removed upon completion of the works);
- Where shroud and banner advertisements are considered acceptable on listed buildings or in conservation areas the advertisement should not cover more than 10% of each elevation and should not be fragmented

The proposal does not comply with any of these criteria. Fundamentally, there are no current or planned construction works taking place at the premises, for which the proposed shrouds would act as a screen. Rather scaffolding would be erected for the express purpose of supporting the advertisement to the Camden High Street elevation, which would by nature not be temporary, and this goes directly against the spirit of CPG1 guidelines.

In terms of appearance also proposals are unacceptable, as the shrouds would not contain a 1:1 image of the building and would screen an area far greater than 10% of the elevations they are placed on. Covering almost all of the front elevation above ground level, and a significant proportion of the side elevations, the combined visual impact of the shrouds would be damaging to both immediate and longer views of the site.

The shrouds may not be deemed to detract from the host building, given that it is considered a negative contributor within the conservation area, but their combined prominence would be overwhelming within the wider setting, and would certainly not preserve or enhance the character or appearance of the conservation area. This prominence is exacerbated by the proposed installation of external lighting to the front elevation, which would extend the visual impact of the shrouds after dark.

Public Safety

Given the position of the proposed shrouds above ground floor level and intention to externally illuminate the front elevation advert, proposals are considered to raise significant public safety issues.

The combination of size, location and method of illumination of the adverts poses a dominant visual distraction and is considered to be harmful to motorists travelling northwards along the busy Camden High Street network, which falls on a TFL Red Route. For these reasons proposals are contrary to DP21 which makes clear that the Council expects works affecting highways to avoid causing harm to highway safety.

Recommendation

The proposed adverts by virtue of their excessive size, prominent location and illumination, would harm the amenity of the street scene and Conservation Area, contrary to policies CS14, DP24 and DP25 of the Local Development Framework, and cause detriment to public safety contrary to policy DP21. The application is therefore recommended for refusal.
