All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 and DP25 of the London Borough of Camden Local Development Framework Development Policies.

Reason: For the avoidance of doubt and in the interest of proper planning.

The side facing window on the first floor side extension hereby approved shall be obscure glazed and fixed shut and shall be permanently retained and maintained as such thereafter.

Reason: To protect the privacy of adjoining occupiers in accordance with policy CS5 of the London Borough of Camden Local Development Framework Core Strategy and policy DP26 of the London Borough of Camden Local Development Framework Development Policies.
