FRONT GARDEN AREA:

Acacia - Regrowth from an old stump

We advise: Lightly reduce and prune to shape (1.5 metres maximum).

Fig - Overhanging front pathway.

We advise: Cut back spread over pathway to front of house. Cut back remaining spread to leave a more compact specimen.

Mature Lime - located on rear boundary. Tree previously reduced, its crown has now grown extensively since that time and is beginning to shed branches into the adjacent garden.

We advise: Remove basal growth and epicormic shoots. Cut and kill ivy. Thin regrowths by 25%. Reduce height and spread by 2-3 metres.
